#### **Presidents Minute**

Officer's reports are mostly a look back over the previous year or 6 months. If I was writing this in December 2019 I would be thinking we had a pretty good run in JAD through the year: 2 strong Conventions, LeadAC, Top Gun, IQT, great representation at various International Events (MidWinter, Leadership Summit, Internationals, Harmony U, Judging Category School, District President's Council, etc.). Strong new Officers, productive Board meetings, and our Budget held up fine.

Then 2020 starts out with a bang – a great Top Gun, MidWinter (Hearsay - Seniors champs!), and LeadAc. I'm thinking 2020 is going to be even better as we start preparing for a new JAD President in 2021. Then we start hearing about Covid and everything changes......1<sup>st</sup> casualty is IQT which gets cancelled last minute, and then Spring Convention gets cancelled. And the dominoes keep falling – International is cancelled, Harmony University moves to an on-line model, and other events are in question.

Perhaps more importantly to our personal Barbershop lives, Chapter rehearsals get cancelled and ALL of our shows and sing outs are cancelled. Where we used to gather with our singing buddies at least once a week to ring some chords, sing great songs, and enjoy tons of fellowship – it's like we fell off a cliff cold turkey.

Slowly, most chapters start finding virtual substitutes – Zoom meetings to keep gathering and replace inperson rehearsals, phone trees to reach out and stay in touch, and tons of emails. Folks get more and more creative with filling the vacuum – education we might not ordinarily do at an in-person rehearsal, guest speakers, and more self-work on the members' side.

But as we settle in for a very different barbershop life in the short term we start seeing medical and choral experts state that group singing is the worst environment for spreading this disease. And choral settings are likely to be the LAST gatherings to get back to normal. Sigh – we just can't catch a break.

Which brings us to today. All levels of leadership (Chapter, District, and International) are working hard to fill the gaps and keep the Barbershop flame alive - whether through sharing of tactics for virtual meetings, new programs from BHS (group meetings and free Friday classes), regional calls within the District, and now this group HoD meeting. Individual efforts like the Core Challenge, lots of on-line chat and discussions, and a bunch of tags being posted give other ways to satisfy our hunger for barbershop. While not the same as weekly rehearsals or in-person District events, the creativity and desire to continue our great hobby under such difficult circumstances is quite impressive.

What about the future? By now you have likely seen the resolution adopted by the JAD Board: we are recommending against resuming in-person Chapter rehearsals until National and International Health groups judge such meetings safe. As of this writing the Fall Convention has not been cancelled – but my sense it is hanging by a thread. Not just whether we can gather in October but how soon BEFORE the Convention can a chapter or quartet safely meet. Events beyond that are simply at the mercy of how quickly the pandemic passes and we can resume our in-person gatherings.

In summary we have not faced such a challenge for a long time – if ever. I am so excited (and frankly proud) of how barbershoppers as a whole have managed this set-back, and I expect the ideas and events to continue to expand. So stay positive, stay safe, and keep singing.

- Participated in the committee to create the 2020 Summer Shindig

  - o Set up website portal for the event
  - o Subsequently deleted all references.
- Communication Methods During Pandemic
  - There are no great methods for conducting any real choral rehearsal using online streaming services currently. The technology and the bandwidth simply are not there yet.
     I would imagine something emerges in the next year to fill that gap.
  - Numerous options are available for conference calls including Zoom, Skype, Facebook Messenger, and Google Meet. These are all relatively easy to use, even for those with technology issues, and free. Conference calls are a great way to keep members in contact with each other in masse. They require some discipline during the call to make sure people aren't talking over each other.
  - During conference calls, learning tracks can be played while everyone is muted, allowing everyone to sing through a song at the same time, and get immediate coaching from the director on possible pitfalls in the music and things to remember.
  - Recordings of individuals singing along with learning tracks can be made easily using free apps on a smart phone and emailed to the director or music team for evaluation.
  - Individual vocal lessons are far more practical than group rehearsals using video conferencing.
